Introduction

Education determines the intellectual prowess of a nation and ensures a systematic and assured course towards prosperity. Developed nations have a system of uniform quality education available to all segments of society in the formative stages through public and private institutions. Unfortunately, majority of our talented youth are deprived of this opportunity for a host of reasons and thus a *raison d'être* for the creation of Al Mujtaba Education Trust. Al Mujtaba Education Trust (AMET) was established in Jan 2016. After formulation of the Trust Deed and Bye Laws it was registered in February 2016 under Societies Registration Act, XXI of 1860 vide Registration No 47/2016. Thereafter, standard operating procedures (SOPs) regarding accounts, general and zakat donations, selection of beneficiaries and monitoring procedures were prepared. Trust activities are managed by an Executive Committee while the Board of Trustees oversees the working of the Executive Committee and takes major policy decisions. Members of the Board of Trustees as well as the Executive Committee are elected as stipulated in the Trust Deed.

Vision

Our vision is to ***'break the poverty – illiteracy linkage'***. We intend to contribute towards the creation and sustenance of an environment where talented and needy students have access to scholarships and interventions that address resource gaps affecting the realization of their true potential.

We visualize a state where every talented and needy child gets fair opportunities to become responsible and productive member of the society.

Mission

Provide financial assistance to talented boys and girls from poor families to enable them to study and excel in existing or higher quality schools, colleges and institutions of technology. Establish Educational / Vocational / Technical training facilities at selected rural/urban areas. Where necessary, assist educational institutions in improving teaching skills of their teachers.

Objectives

- Support the education of needy talented students by bearing expenses on fees, uniforms, and conveyance etc., and where necessary, have them admitted in higher quality institutions.
- Facilitate technical and vocational training for boys and girls who have aptitude, thereby enabling them for suitable jobs on a fast-track basis.
- Establish Educational/ Vocational/ Technical Training facilities at selected rural/ urban areas.
- Support students demonstrating good academic record and desirous of higher education to enable them to graduate in disciplines of choice.
- Assist capacity building in selected schools where such facilitation has convergence with objectives of the Trust.

Scholarship Award Policy

Purpose. Ensure that students selected for award of scholarships are the most deserving in accordance with objectives of the Trust.

Scope. The policy covers aspects related to selection of students for award of scholarships. While the policy covers all general considerations involved in processing student applications, case specific/additional issues needing special handling cannot be ruled out. Chairman of the Trust and Executive Committee are authorized to handle and manage any deviations deemed essential and suitable to the situation/case in hand.

Policy Framework

Principles:

- Following principles form the cornerstones of the policy:
 - ❖ Incorporation of fair, criteria based, and transparent selection process
 - ❖ Gender-based equalization of opportunities.
 - ❖ Maximization of outreach to extend benefits to all areas of the Country.
 - ❖ Maximization of coverage of education streams.
 - ❖ Sustainability.
- The process of selection is kept simple and flexible by design with provision for due oversight. It regulates the following aspects:

- ❖ Education levels for which scholarships will be awarded.
- ❖ Criteria for selection of beneficiaries.
- ❖ Selection Process.
- ❖ Roles and Responsibilities.

Categories/Levels of Education

Students of following education streams will be eligible for award of AMET scholarships:

- Secondary (SSC) and Higher Secondary School Certificate (HSSC) levels.
- Vocational/Skill Training Courses
- **Technical Courses.** Diploma and Certificate Courses in contemporary disciplines, Diploma Associate Engineer (DAE) Courses.
- Higher Studies (Graduation) at university level less PhD/M Phil.

General Criteria

- Talented students belonging to economically challenged families are eligible. Duality is not allowed in that, students receiving financial support from any other source, otherwise eligible are not considered. The following criteria is applied:
 - ❖ **Good Academic Record.** Must have scored minimum A Plus grade marks in previous formal examinations with priority to: -
 - Students at rural Govt schools.
 - Students at private schools where Govt Schools are not available, inoperative or lacking specific subject teaching facility.
 - Orphans will be especially facilitated.
 - ❖ Recommended by administration of school where enrolled and/or Trustee.
 - ❖ Students who have lower grades but still recommended by Trustee/Community representative and/or school administration on basis of their potential and/or marginalized status of family will be supported after independent evaluation carried out by the Scrutiny Committee (SC) nominated by the Chairman.
 - ❖ Un-enrolled children of poor families/orphans/madrassa students/ street children (separated from families) are considered as special cases and supported on case-to-case basis as decided by the Executive Committee. Recommendations for consideration for such cases may be made based on any of the following criteria:
 - Personal information of Sponsor/Project Director (PD)

- Recommendations of community representatives.
- Any other reliable source of information.

Specific Criteria

Secondary School Certificate (SSC)/Higher Secondary School Certificate (HSSC)

- Candidate must have secured:-
Admission in Matric Classes: Minimum Marks in Class 8
 80% for Punjab and KPK Provinces.
 75% for Sind and Balochistan.
Admission in Intermediate: Minimum Marks in Matric
 75 % ; 70 % marks for **orphans only**.
- Candidates must have sought admission in a registered/ recognized school/college.
- Recommendations by the head of the institution and PD.
- **Continuation of Scholarship.** Minimum 70% Marks in Annual Exams.

Higher Education and Technology Courses Additional Criteria

- Candidates must have secured admission in HEC recognized Colleges/ Universities/ Institutes through their own efforts.
- Must have scored the following minimum percentage marks for respective levels:
 - ❖ **Higher Education.** 75%
 - ❖ **DAE Courses.** 60% in Matric or Entrance test of respective technical institution.
 - ❖ **Skill Certificates.** As per requirements of course. (Preferably 60% in Matric or Entrance test of Institute).
- For DAE courses and Skill Certificates nominations (in accordance with Trust criteria) from partner institutes evaluated by Trust are given preference.
- Existing beneficiaries coming through lower levels are given extra weightage marks (as determined by the 'Executive Committee) for merit evaluation. Consideration of such cases is subject to meeting other criteria laid down for selection for Higher Education Scholarship.

- Continuation of support is subject to academic performance. Achievement of the following minimum grades is mandatory:
 - ❖ **Higher Education.** Minimum 75% or equivalent GPA (2.75).
 - ❖ **DAE.** Minimum 60%.
- **Vocational Training In Rural Areas.** Young persons residing in rural areas are eligible irrespective of education qualifications. Preference is given to girls who are matriculate.

Selection Process

Budgetary Allocation. The number of beneficiaries to be supported depends on resource availability for the academic year. Subject to inflow of funds, draft plan for distribution of resources amongst various education levels is evaluated by the Executive Committee (EC) and approved by the Chairman on following basis: -

- ❖ Availability of funds for continuation of scholarships for enrolled beneficiaries.
- ❖ Donor preferences for streams of education to be supported.
- ❖ Balanced distribution amongst genders, geographical areas, and education streams. The number of students for each level is determined on an annual basis.
- ❖ Budget estimates and targets set for different levels of education are approved by the EC on a yearly basis.

Identification of Potential Beneficiaries

- Needy and talented students meeting Trust criteria of academic record can apply directly to Trust. Applications are to be sent to Trust office on prescribed forms downloadable from Trust website 'almujtaba.pk' or acquired from Trust office.
- Trustees nominated as PD will recommend potential candidates for AMET support and facilitate their selection process.
- Tests/interviews etc., will be conducted by AMET if/when considered necessary.

Consideration of Beneficiaries for Selection

- Recommended cases are scrutinized by 'Scrutiny Committee' (SC)

nominated by Chairman Trust for shortlisting prior to discussion in EC meeting for final approval.

- Donors may nominate specific cases for award of scholarships out of their donations. Such nominations are included as a special category, however, approval in EC meeting is mandatory. In case the EC considers a nomination at variance with Trust policies, alternate names will be requested or proposed for concurrence by the donor.
- Selection is finalized and approved by the EC. Chairman is the final arbiter.
- PDs act as sponsors for respective candidates.
- **Frequency of Selection.** Selection of beneficiaries is carried out in accordance with admission schedules of academic institutions. Exceptions are considered on case to case and on required basis.

Selection of Candidates. The following process is adopted:

- Allocation of budget for AMET support.
- Identification of candidates and recommendations by PDs for inclusion in shortlists for AMET support: -
 - ❖ 'Candidate Registration Form' is filled in and endorsed for each proposed candidate for AMET support by respective PDs as well as members area coordination committees.
 - ❖ Where necessary, confirmatory tests by Member/Committee designated by EC are carried out.
 - ❖ PD/ Senior Member Coord (SMC) presents comparative evaluation of candidates in case resource constraint necessitate limits on number of scholarships.
- Short Listing and preparation of provisional list by SC.
- Final Selection
 - ❖ Case of each candidate included in short-list as potential beneficiary is presented in Executive Committee (ECM) Meeting for approval. Information provided in 'Beneficiary Registration Form' forms the basis of consideration.
 - ❖ Chairman may approve inclusion of exceptional cases other than those shortlisted by 'Scrutiny Committee' (SC).

Support Package

- Financial support levels vary in accordance with the needs of beneficiaries.
- While all expenses related to education including fees, books, transport/ hostel charges, uniform etc., are eligible, actual grants are made on required basis as decided by the EC.
- Sustainability for the entire duration of the course is ensured.
- Part payments, one-time grants and returnable time-based loans may be considered on case-to-case basis.

Monitoring and Evaluation

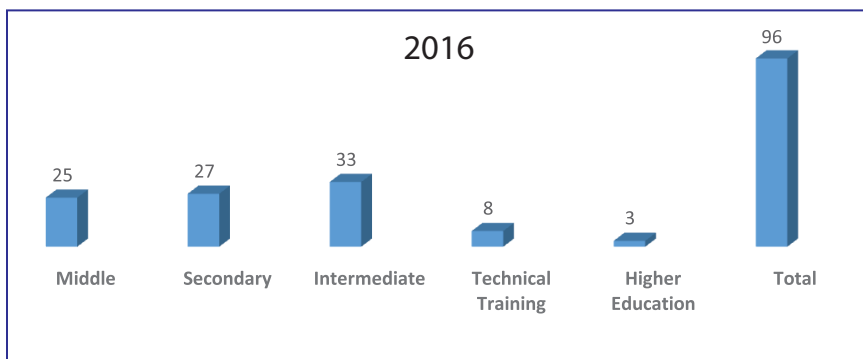
Beneficiaries are monitored by respective PDs who engage with students, parents, and respective academic institutions. The following aspects are included in the monitoring activities: -

- Academic results and records of funds allocated as the beneficiaries' progress through academic years. Case files for all students are maintained.
- Counseling of beneficiaries who fail to achieve minimum essential grades. A graduated approach from counseling to warning to penalty or suspension of scholarship and if necessary, termination of scholarship, is adopted allowing maximum possible opportunity to the beneficiary to improve.
- Facilitation to beneficiaries for resolution of any issues having potential to impact studies.
- Recommendations for continuation/reduction/suspension/discontinuation of support in case of persistent dissatisfactory progress and/or matters related to conduct.

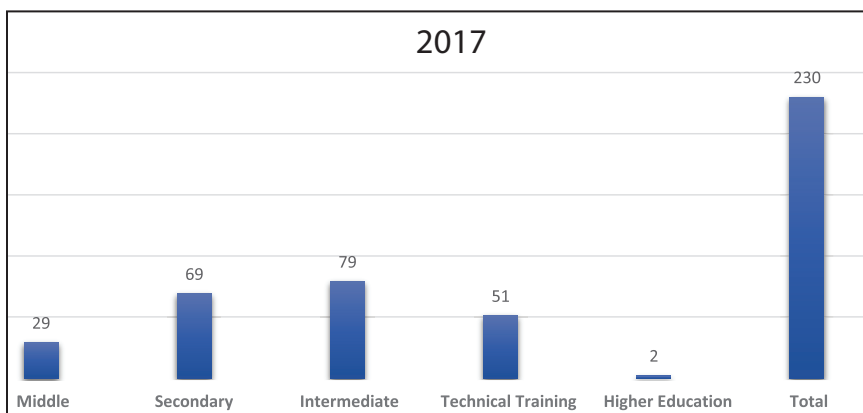
Termination/Withdrawal of Scholarship. In case of continued and persistent unsatisfactory academic performance or conduct, scholarship is terminated. Scholarships of beneficiaries who manage to get financial support from any other source are also ceased.

Policy Review. The policy is kept under regular review.

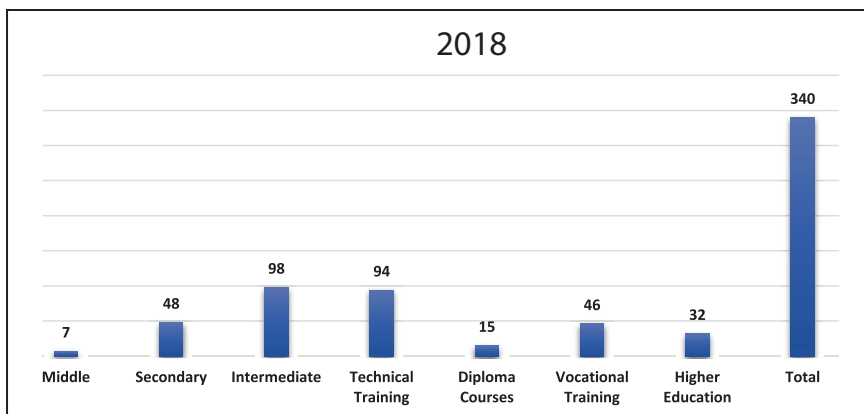
Education Streams And Scholarships Awarded Since Inception



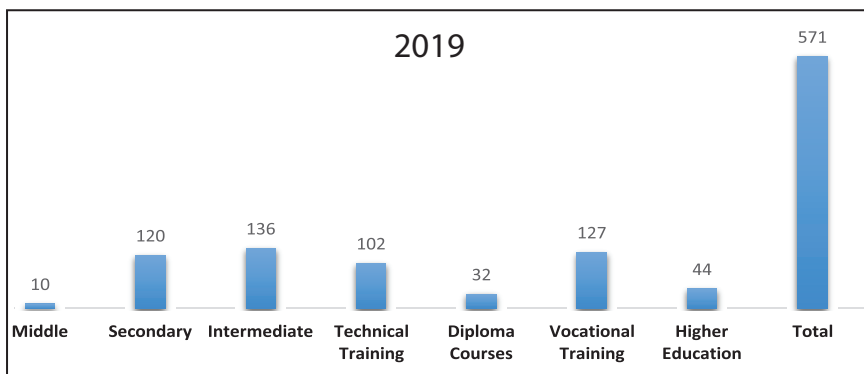

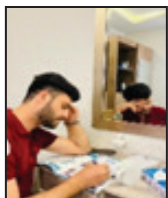
Faiz Rashid Malik

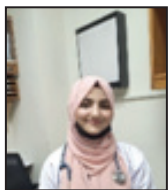
Urooj Bibi

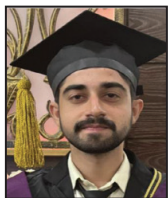
Naruminullah

Nasruminullah belongs to Pandi Lalma, Khyber Agency, an economically underdeveloped area. His father had to support seven children through meagre earnings as a driver, a situation which dented Nasruminallah's prospects to pursue higher education. He, however, did not give up and decided to help out by working part time as a salesman in the vegetable wholesale market. Simultaneously he enrolled in the Sociology Department, University of Peshawar. Till the 5th semester he managed part time work daily after classes, on weekly holidays as well as during vacations and still achieved CGPA of 3.64. The demanding routine, however, was becoming difficult to maintain and he started facing difficulties in putting in the required hours of work to earn enough to pay semester fees. He was on the verge of dropping out, when on the recommendations of his institution, he was selected for AMET scholarship. He has since graduated and as he seeks suitable employment, he remains engaged in teaching children driven by his motivation to pay back to society.

Dr Qurat-ul-Ain has been a recipient of Al-Mujtaba Education Trust Scholarship since she was in Matric and is now a medical doctor. Maria Afsar belongs to Mirpur Azad Kashmir. She is the daughter of a security guard and was awarded scholarship for 'Diploma in Physiotherapy (DPT)' at the University of Faisalabad (TUF). She completed her graduate degree with a CGPA of 3.47 which earned her employment as a physiotherapist for Special Children, in her hometown. As a gesture of gratitude and in accordance with her father's wish, she donated her first salary of Rs 25,000 to AMET. Her generous spirit to pay back to society reflects our positive cultural values and kindles great hope. It also endorses the viability of our organizational vision of **'breaking the illiteracy dropout linkage'**, through educational opportunities to needy and talented students.

Girls in Rural Areas

We believe that girls from rural areas possess tremendous talents. When provided with opportunities they display great enthusiasm and energy in learning new skills. Emphasis on soft skills in training programs also enhances social awareness and helps harmonious relations amongst their communities.



Collaboration with other Organizations & Technology Institutes

The Hunar Foundation (THF)

A Memorandum of Understanding (MOU) was signed in 2017 between THF and Al Mujtaba Education Trust (AMET) to equip our youth with employable skills and fast track their earning potential. Currently 130 students are sponsored on an annual basis with 10 seats reserved for girls. The courses span six months and cover multiple disciplines at four campuses, at Karachi (two campuses), Tando Allah Yar and Kharian.

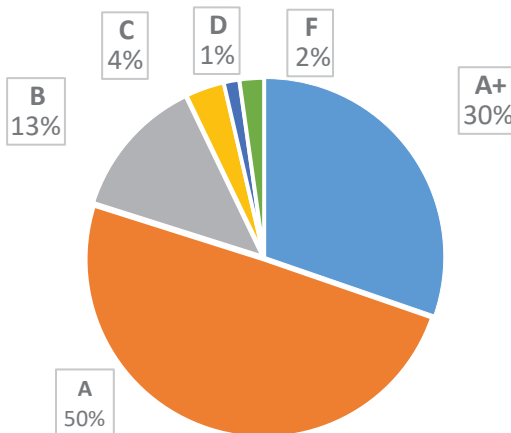
Technological Skills – Certificate Level Courses

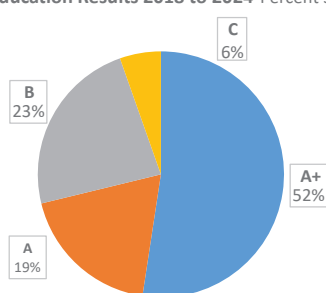
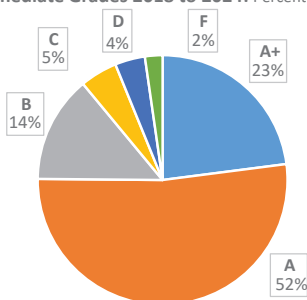
In view of positive outcomes, i.e., fast track employment, industry relevant skills and potential for further studies, support for Certificate Courses has become a major focus area for the Trust. MOU with THF has been augmented with skill training programs for girls at the Saeeda Nasim Technical Institute (SNTI) at Karachi. At the THF campuses over 700 students have been trained so far while at SNSC 10 girls are sponsored annually. All sponsored students qualified with good grades and nearly 70% of them are reported as employed in local industrial concerns. A significant number are self-employed and some have gone on to higher studies. Plans are in hand to augment this stream at other institutes also as resources become available.

General Scholarships: Percent of Students in A+ and A Grades

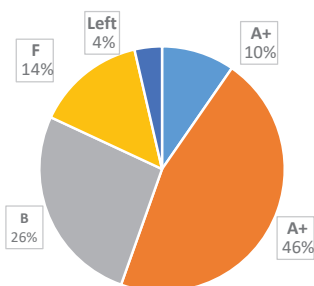

Vocational Training

Concept: A large segment of the rural female population continues to be “unskilled” and unable to utilize their true potential. Responding to this situation, seven Vocational Centers (VC) set up in rural areas are operational. This program has been possible due to the generosity of Trustees who have dedicated their personal properties for the centers at Chawali, (District Chakwal), Sillanwali, (Distt Sargodha), Bucha (Near Mandra - District Rawalpindi), Rera, (District Bagh – AK), Baffa (District Mansehra) Jewra near Kahuta, (District Rawalpindi) and Khabeki (District Khushab).

Courses Conducted. Two six-month ‘Dress Making’ courses per year are conducted at each VC. ‘Basic Computer Training Courses’ have also been added at two centers in 2024 to enhance the skill options. Similar initiatives will be undertaken at all centers as resources become available. The curriculum includes general awareness and motivational, religious enlightenment. In 2024, 323 girls were trained out of which 77 underwent computer training.

Enhancing the quality, scope, and reach of our vocational training programs remain the core objectives of our Trust. A dedicated facility, the AMET EDUCATION COMPLEX, is being developed accordingly. The complex is envisaged as a center for leadership and guidance, fostering contemporary and advanced skills. It embodies AMET's commitment to provide high-quality education and skill development opportunities to underprivileged youth. The project follows a phased construction strategy to ensure efficient implementation, with completion targeted for 2026, subject to funding availability (estimated at PKR 200 million). The complex will include:

- Paramedic training center
- IT and digital skills training facilities
- Foreign language training for skilled workers
- Government school teachers' training programs
- An innovation and emerging skills hub
- A prayer hall and Islamic library
- The AMET office


